<u>O R D E R</u>

- 1. We have heard learned counsel for the parties.
- 2. This statutory appeal is directed against the order dated 19.12.2023, passed by the Bar Council of India, whereby the appellant-advocate has been held guilty of professional misconduct and punished with three years suspension from the roll of advocates maintained by the State Bar Council.
- 3. Having regard to the serious misconduct carried out by the appellant-advocate, who appears to be an obstinate character in making scandalous allegations against the respondent-complainant, we do not want to take any lenient view. The appeal is accordingly dismissed with a cost of Rs.1 lakh.
- 4. The Collector, Agra is directed to attach the properties of the appellant for recovery of the cost amount, which shall be paid to the respondent (*Priyanka Bansal*) as compensation within a period of three months. The Bar Council is directed not to renew the license of the appellant without prior permission of this Court.
- 5. It is further directed that after the appellant undergoes the sentence already awarded to him, a Report in that regard shall be
